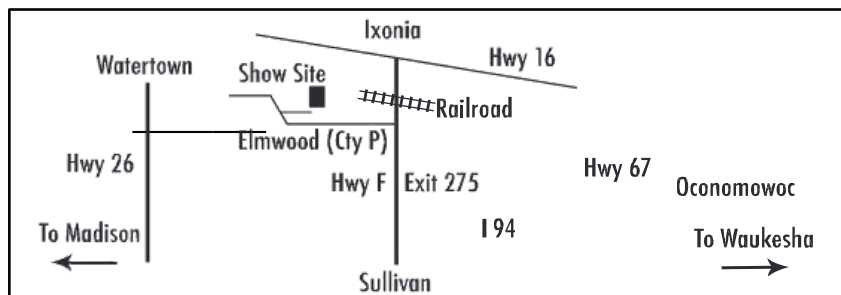

SHOW SITE is approximately 17 miles northwest of Delafield via Interstate 94 West, Concord exit #275 for County Road F. Continue north on County Road F for about 5 miles (lots of curves so be careful); turn left onto Elmwood Drive (before railroad tracks); then take the first right onto Cedar Drive. Show site on left at end of the street (white metal building). See special arrow signs on the corner of County Road F, and Elmwood Drive to direct you to the show site.

Canine Good Citizen and Trick Dog Testing!

Cost: \$20 per dog/per test

The Canine Good Citizen Program is a two-part program. First: to teach responsible dog ownership to owners, and second: to certify that dogs have the training and behavior needed to be reliable.

CGC tests are noncompetitive. Dogs are not required to perform items on the test with the same precision needed in formal obedience trials. ***The test will be held on Saturday morning after Obedience/Rally judging and before Conformation judging.***

Trick Dog test will follow CGC evaluations. You must bring your Props for the Trick Dog Test.

Props for Trick Dog will NOT be supplied by GMNEA.

You can sign up using the entry form. There will be a combined limit of 10 dogs for CGC and Trick Testing.

If this limit is not met, we will accept day of show entries.

JUNIOR SHOWMANSHIP COMPETITION

OFFERED AT SATURDAY SHOW #1 AND THE SUNDAY SHOW

NOVICE CLASS: All ages, who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice class at a licensed or member show.

OPEN CLASS: All ages, who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

BEST MASTER HANDLER: All ages, who at the time entries close, have won ten (10) first place wins in an Open Class, with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 - October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participant return to the Open Class to complete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

Sanctioned Four-to-Six Month (Beginner Puppy)

Competition Regulations

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.
- Classes will not be divided by sex in this competition.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign-born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. "Exhibition Only" entries are not eligible to earn awards in this Competition.
- Dogs that are owned or co-owned by a professional handler, members of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.
- Exhibition Only entries may not be changed to be eligible to compete for awards after the close of entries.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Changes, additions, or corrections to entry forms must be received in writing (email acceptable) only prior to the closing date and time of entries.
